7 October to the Deputy Returning Officer, Cornwall Council, Mayor's Parlour, St John's Hall, Alverton Street, Penzance, TR18 2QR, between the hours of 10.00am – 1.00pm and 2.00pm – 4.00pm

- **POLLING DAY**

If the election is contested, the poll will take place on **Thursday 6 November 2025**.

New applications to vote by proxy at this election must be sent to the Electoral Registration Officer by not later than 5.00pm on **Wednesday 29 October 2025**, except in cases where **unforeseen illness, incapacity, occupation, service or employment** occurs after that time, in which case applications may be received by no later than 5.00pm on **Thursday 6 November 2025**.
